



BUCKDEN AND DIDDINGTON PARISH COUNCIL TREE STRATEGY 2020

1. Strategy Aims

1.1 The Parish Council accepts its duty of care to maintain its trees in a safe condition and that will remain as its priority. It also recognises the contribution trees can make to our local community aesthetically and practically, while also providing habitats for birds and insects. For these reasons, the Parish Council will continue to manage its tree assets sustainably and in accordance with best practice. It will adopt the following approach.

- Maintenance: To manage the current stock of trees in accordance with current best practice and within the resource allocated
- Protection: To view trees as valuable community assets and to protect them where appropriate
- Enhancement: To enhance the tree cover across the Parish through influencing future developments and by planting the right trees for the right places

2. Managing the Current Stock of Trees

2.1 The legal position is that the owner of the land on which a tree stands, together with any party who has control over the tree's management, owes a duty of care at common law to all people who might be injured by the tree. The duty of care is to take reasonable care to avoid acts or omissions that cause a reasonably foreseeable risk of injury to persons or property.

2.2 The challenges of maintaining our trees come from a changing climate, pests and diseases, an ageing tree stock, damage to roots and pressure from increasing population. It has to be accepted that trees are living organisms and therefore naturally lose branches or fall. Statistics show that the risk to human safety posed by trees is extremely low: Office for National Statistics recorded an average of 6.4 fatalities per year between January 1999 and January 2009, due to falling branches and trees, giving a risk value of 1:10 million for individuals. This points towards taking a proportionate approach to tree safety. Public safety is not however, the only concern when deciding how to manage trees. Other broader concerns such as ecological, landscape and aesthetic value should also be taken into account.

2.3 On the basis of guidance available and its duty of care, the Parish Council will manage its current stock of by:

- Managing the risk of significant injury or property damage to levels that are as low as reasonably practicable
- Operating a system of proactive and reactive tree inspections
- Maintaining a record of trees and inspections
- Ensuring individuals who carry out inspections are competent to do so
- Ensuring work identified through the inspection programme is undertaken by suitably qualified staff or contractors

2.4 To assist in the management of its trees the Parish Council will endeavour to ensure a volunteer Tree Warden is in place, who will be required to complete the LANTRA Awards Basic Tree Survey and Inspection course. In addition, they will be expected to be aware of

an issues notified by the Tree Council and to seek advice from Huntingdonshire District Council Tree Warden Co-ordinator when appropriate.

2.5 The first task in managing the trees is to identify the current stock. There are many trees within the Parish boundary that are not the responsibility of the Parish Council. These include those within the School grounds, in Buckden Towers, on Village Hall Trust land, in Buckden Marina, on private land and in private gardens. There are also trees that are managed by other public bodies such as Huntingdon District Council or Highways England. This strategy excludes all those trees outside of the direct responsibility of the Parish Council. Albeit that the Council will pass on any issues raised concerning other trees to the appropriate person or body.

2.6 The baseline for the current stock of trees is taken from the survey completed by Hayden's Arboricultural Consultants Limited in 2018. At that time the Parish Council had responsibility for 109 trees of which since 4 have been felled, following the adoption of the recommendations from the report. The Parish's 105 remaining trees are listed in the Tree Log at Annex A by tree number, species and location.

2.7 To aid the determination of the level of inspection required, each tree has been allotted a footfall zone and a failure impact category.

Zone	Description
1	Area of heavy vehicle and/or pedestrian use
2	Area of medium vehicle and/or pedestrian use
3	Area of low vehicle and/or pedestrian use

Category	Description
1	Impact of branch loss/tree fall potentially severe
2	Impact of branch loss/tree fall potentially moderate
3	Impact of branch loss/tree fall potentially low

2.8 There is no required interval for tree inspections, although it seems to be common practice to conduct a full check every 3 years. This is therefore the approach the Parish Council will adopt. An ARB contractor, approved by the Arboricultural Association, will be employed to conduct a full tree health and safety survey of the Parish's stock of trees every 3 years.

2.9 The Parish Council has decided that additional checks on its trees should be conducted annually, in line with its duty of care. A combination of the zone in which the tree is found and its impact category will be used to determine who should undertake these checks.

2.10 It is recognised that there may be occasions when additional checks are required at short notice, in particular if there has been a violent storm, which may result in work required outside of the 3 year maintenance cycle.

2.11 The recommendations from all inspections should be discussed by the Parish Council Tree Advisory Group and their report along with a schedule of any required works shared with the Council. The Advisory Group can commission work without full Council approval provided it is within the budget allocated and less than £500. All tree works will have to be carried out to an approved industry standard, in accordance with BS 3998: 2010 'Tree Work Recommendations' and adhere to the requirements of the [Wildlife and Countryside Act 1981](#) in relation to the protection of wildlife. If the work is a matter of an 'imminent threat to life', immediate action is to be taken by the Parish Clerk and the Chair of the Council including the issuing and positioning of warning notices.

2.12 If the work involves the felling of a tree with a trunk diameter greater than 75 mm, as measured

1.5 m above the ground, or the cutting back of a tree by over 30% of its canopy then residents are to be notified. This will be achieved by placing the information on the Parish Council's website, one month prior to the work with contact details, so residents can challenge the decision. The final decision will reside with the Chair of the Parish Council.

2.13 The tree inspections will focus on health and safety issues but also take in to account amenity and environmental factors. The key areas will be:

- Health of tree
- Likely lifespan of tree
- Probability of failure of structure
- Obstruction to line of sight for vehicles
- 2.25m height clearance over a footpath and 2.75m over a cycle path
- Obstruction of street lights
- Undue contact with buildings
- Interference with utility overhead wires
- Need for measures to address trip hazards

3. Protecting the Trees

3.1 There are steps the Council can take to protect its tree stock from deterioration and felling. These include regular health checks, reducing compaction around the roots, applying for Tree Protection Orders (TPO) and where possible seeking to protect trees from felling or unnecessary pruning. It should be noted that there is no obligation on the Council to agree the felling or top/root pruning of its trees in the following situations:

- To allow for the creation of a drop kerb
- To allow building works to proceed
- On receipt of a nuisance complaint beyond that a tree is dangerous trees and/or causing actual damage to property

The latter therefore protects trees against claims of loss of light, disturbance to TV reception, obstruction of view or minor seasonal issues such as leaf fall, bird droppings or honeydew. The Council takes the view that trees be retained for the benefit of wider

society, even where they cause minor inconvenience to immediate residents. The Council can consider agreeing to pruning works to be carried out at the householder's expense. Such work however, would only be sanctioned if the householder confirmed in writing the scope and nature of the work to be undertaken and agreed that they would not be exceeded. This agreement would also need to be acknowledged in writing by the appointed contractor. The Council will only consider sanctioning such work if the appointed contractor is an experienced arboriculturalist and the application for work is accompanied by copies of their insurance certificate and qualifications.

3.2 The Parish has a number of trees issued with TPOs and a Conservation area; the details of which are shown in Annex B (orange highlight denotes query lodged with Huntingdonshire District Council). None of these trees form part of the Council's tree stock. The Council however accepts that all trees within the Parish boundary are important for the local environment and the residents. It will therefore assist Huntingdonshire District Council with the monitoring of TPOs and make recommendations, where it is felt to be appropriate, to issue further TPOs.

4. Enhancing Tree Cover

4.1 The sustainability and health benefits of living within an area with an adequate tree cover are well documented. Trees help to improve air quality, which is important for a village surrounded by major roads. They also help with surface water flooding and biodiversity. Equally importantly trees create an environment that enhances people's wellbeing. Recognising these factors the Parish Council is keen to take every opportunity to increase the area's tree cover.

4.2 Unfortunately the current mix of tree species in the Parish is limited and there are many trees of a similar age. The lack of a broad species mix renders the tree stock vulnerable to being reduced significantly by disease. While the lack of age diversity could mean many reach the end of their lives at the same time. There is a definite need to improve diversity across the tree stock through tree replacement and further planting.

4.3 When planting new trees the Council will take the following factors in to account on the basis of 'right tree, right place':

- The landscape character of the area
- Soil type, climate and site factors e.g. shade from buildings, impact on the current habitat
- Expected lifespan, height and spread; to favour large trees wherever possible
- Risk of soil compaction around roots
- Capacity to support local fauna
- Government advice on sourcing trees to reduce the risk of introducing pests and diseases
- Improving species diversity
- Preference for broad canopy species as opposed to ornamental trees (helps protect against flooding and the amelioration of high temperatures)
- The location of over/underground infrastructure

- Planting within hard surfaced area should make use of underground structures to ensure sufficient rooting environments for species selected

4.4 The Council should view the planting of new trees as an opportunity to involve the local community. For example the community could take on responsibility the creation and siting of nest boxes. Most importantly, the Council must endeavour to maintain newly planted trees appropriately to ensure they have the best chance of establishing.

4.5 Development can have a significant negative impact on trees. The Council, when assessing planning development proposal applications, will aim to ensure attractive and valuable landscape features including high quality trees are retained as part of any development. For any planning application where there are trees on or adjacent to the proposed site, applicants will be expected to provide a tree survey, arboricultural implications assessment and an arboricultural method statement to include a tree protection plan. The arboriculturist should also be able to provide details of protection and mitigation measures for the development (based on the technical guidance in BS5837 (2012) 'Trees in Relation to Demolition, Design and Construction'). The Council will not only seek to protect current trees but will positively engage with developers to ensure that new trees are planted within any development in both the streets and within the grounds of buildings.
